
#### Impact and Vision

#### The Application Process

The application process begins with a comprehensive review designed to be more accessible and less intimidating than traditional pardon applications. This is followed by a preliminary screening conducted by the legal clinics at the University of Akron School of Law and The Ohio State University Moritz College of Law. Law students and faculty members evaluate the applications against the project's eligibility criteria.

Successful applicants then receive guidance on preparing their official pardon application to the Ohio Parole Board. This preparation includes assembling supporting documents, such as letters of recommendation, evidence of community service, and any awards or recognitions received. The legal clinics play a crucial role at this stage, offering pro bono legal assistance, helping applicants navigate the complex legal requirements, and ensuring their applications are as compelling and complete as possible.

#### The Expedited Review Process

Once submitted, the applications undergo an expedited review by the Ohio Parole Board, a process that significantly reduces the waiting time for consideration. The Parole Board conducts a thorough review, including interviews with the applicants, before recommending to the governor. The expedited nature of this review contrasts sharply with the traditional pardon process, which could take years, highlighting the project's commitment to offering timely relief to deserving individuals.

#### Impact and Success Stories

The Expedited Pardon Project has seen numerous success stories, with individuals granted a pardon experiencing profound life changes. Freed from the stigma of a criminal record, they find improved employment opportunities, access to better housing, and the ability to participate more fully in their communities. 




